The new IFS PACsecure version 3

IFS is pleased to announce the publication of the IFS PACsecure version 3. IFS PACsecure is our standard for packaging materials that was developed by the industry for the industry. Accordingly, it has a unique market and practical approach. Together with international experts representing the various links along the packaging supply chain, such as the IFS Technical Committee, IFS Working Groups and PAC Global, we developed a new version considering the latest developments, regulations, and our stakeholders' needs. We paid particular attention to making working with the standard easier, more efficient, and more practical for auditors and companies.



IFS PACsecure version 3

The most significant changes and improvements



The **restructured checklist follows the audit process more consequently**. It increases the audit's efficiency. For example, product defence is now part of chapter 4.



The **total number of audit requirements were slightly reduced** due to optimisation in the checklist, and we included four new requirements.



The **standard logo becomes a new, modern design** with the start of version 3.



The **B-score is again classified as a deviation**. By defining a correction or corrective action, your system will continuously improve.



Companies must define objectives for each of the four dimensions of **product safety culture**.

We clarified the unannounced audit rules and **introduced the IFS Star status to indicate an unannounced audit**.



The **checklist is more consistent, clearer** and better clarifies the intention of the requirements. The word "assessment" becomes "audit" again, in line with ISO 22003-2.

We aligned the standard with the **Codex Alimentarius**, ISO 22003-2 and GFSI Benchmarking Requirements.

IFS PACsecure version 3

Timelines



IFS PACsecure version 3 audits are possible from **1 July 2024** and become mandatory as of **1 October 2024**.

In general, the **applicability of version 2 ends on 30 September 2024**. However, version 2 can apply after 1 October 2024 in some exceptional situations. The general admission of these exceptions ends on 30 September 2025. Here is an overview:

- For **unannounced audits**: Version 3 applies when the audit window starts on or after 1 July 2024.
- For **multi-location audits**: Sites and head office are always audited to the same standard version. After 1 October 2024, version 3 applies to all audits performed at the head office.
- For **follow-up audits**: When the connected main audit took place according to version 2 before 1 October 2024, version 2 also applies for the follow-up audit.
- For **extension audits**: When the connected main audit took place according to version 2 before 1 October 2024, version 2 also applies for the extension audit.



What you should know

Unannounced Audits

Performing one of every third audit unannounced is obligatory. In version 3, we have clarified the counting of the unannounced audits. Please refer to chapter 2.4.2, Part 1, for details.

New IFS PACsecure logo

With the start of audits to version 3, the **new standard logo** will appear on the IFS Certificates and Reports. The current logo still applies to version 2 certificates and reports. The new logo will be **available in the IFS Database** from July 2024.

IFS Star Status

Unannounced audits **increase credibility in the audit process**. It demonstrates that your company implements the IFS Requirements every day. We introduce the **IFS Star status to indicate that the audit was unannounced**. It shows your customers your outstanding engagement. **A star will be visible in the IFS Database and on the IFS Certificate**. We have created a special logo for this purpose.

Scoring System

The **B-score is now classified as a deviation again**. It is more apparent to all parties involved, and by defining a **correction or corrective action**, your system will continuously improve. We updated our brochure, "The IFS Scoring System – Driving Continuous Improvement", which explains it more thoroughly.

Audit duration rules

The rules to increase or decrease audit duration were reviewed and updated but maintained in the doctrine. **In the case of the 50% on-site rule, a reduction is possible in certain situations** which will be described in the upcoming version 3 doctrine.

Action Plan

Your certification body must send an **action plan within two weeks after the audit**. It is no longer mandatory that the CB sends a provisional report. Both audited companies and auditors will benefit from this more efficient and practical working method.

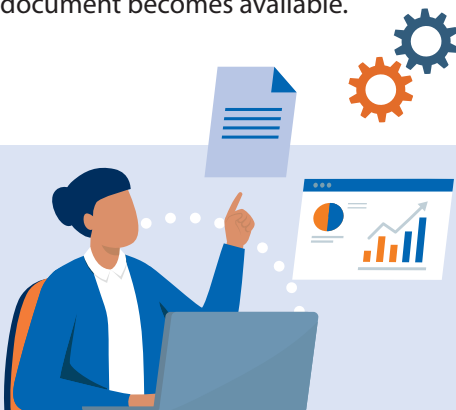
